Note: Recognizing the immediate needs of our customers regarding the upcoming TCAS 7.1 mandate, Rockwell Collins will be extending production on our TTR-921 and 4000's on a limited basis. Production will transition to the new TTR-2100 and TTR-4100 throughout 2015 as each aircraft is added to the AML Supplemental Type Certificate (STC). Demand is expected to increase dramatically as the December 2015 mandate approaches and we encourage our customers to place their orders early in order to avoid a last minute rush.

The TTR-920, part number 622-8971-XXX will need to be replaced with TTR-2100/4100/4000/921. A trade-in credit will only be issued against the purchase of a new TTR-2100 or TTR-4100.
